Refunds and Cancellations Policy

1. Purpose

Passy-Muir is committed to delivering high-quality educational experiences while maintaining transparent business practices. This Refunds and Cancellations Policy outlines the conditions under which learners may cancel their registration and receive a refund, and the circumstances under which Passy-Muir may cancel or reschedule a course.

2. Learner-Initiated Cancellations

Learners who wish to cancel their registration must submit a written cancellation request to Passy-Muir via email at education@passymuir.com.

Cancellation Deadline: To be eligible for a full refund, cancellation requests must be received at least seven (7) calendar days prior to the course start date.

Refund Eligibility:

- Full refund: Requests submitted at least 7 days in advance.
- Partial refund: Requests submitted between 3–6 days before the course start date (subject to a \$25 administrative fee).
- No refund: Requests received within 48 hours of the course start date or for no-shows.

Processing Time:

Approved refunds will be processed within ten (10) business days of the request.

Non-Refundable Fees:

Any materials fees, shipping costs, or processing charges are non-refundable.

3. Passy-Muir-Initiated Cancellations or Rescheduling

Passy-Muir reserves the right to cancel or reschedule a course due to low enrollment, unavailability of instructors, natural disasters, public health emergencies, or other unforeseen circumstances..

If Passy-Muir Cancels:

• Learners will receive a full refund of all paid registration fees or the option to transfer to a future course.
